**Declaration**

In the event Applicant's account becomes delinquent, Peerless Pump reserves the right to accelerate and demand payment of the balance in full. In any action for collection of unpaid sums, Peerless Pump shall be entitled to recover all costs of collection and expenses, including attorneys' fees.

Applicant authorizes Peerless Pump to obtain information as Peerless Pump may require concerning the credit worthiness of Applicant and agrees that this application shall remain Peerless Pump's property. Applicant authorizes Peerless Pump to release information concerning Applicant's credit worthiness to other creditors and to credit bureaus upon written authorization by Applicant to the creditor or credit bureau that is requesting the information about Applicant. Acceptance by Peerless Pump of this application is not an agreement to extend credit to applicant.
